PRICING & PAYMENT

Time based fees remain accurate for a quotation period of 20 days. Any changes that increase the number of hours required over the original estimate is subject to additional fee and extension time.

Payment upon completion of one or more phases of work are due prior to the release of finished drawing. Payment in full is due within 14 days of invoice.
